## FIRST BOARD OF CHANGEMAKERS: GEOECONOMICS

The rise of the Global South, technological disruption, and intensifying humanity-wide crises have reshaped the world's geopolitical balance. Despite this, the IMF predicts steady global growth at 3.3 percent in 2025.
