Business models, supply chains, and innovation bets are being rebuilt around a few hard targets—the energy transition, digital infrastructure, AI, and regional resilience—even as institutions confront widening social divides and mounting fiscal strain.

Across boardrooms and trading floors, a new mandate is clear: **deploy with speed, think with range, and stay decisively ahead of the curve**. Today, trillions are moving from passive strategies into private markets, alternatives, tokenized assets, and newly opened trade corridors.

Global trade this year will exceed \$35 trillion for the first time – an increase of about \$2.2 trillion, or 7%, compared to 2024

Private market AUM will reach \$60 to \$65 trillion by 2032, growing more than twice the rate of public assets

#### 3X MORE FDI

INSIDE GEOPOLITICAL BLOCS

In the three years up to Q1 2024, FDI flows within geopolitical blocs were almost three times higher than flows between blocs


