Launched by the Public Investment Fund under Saudi Vision 2030, the inaugural FII gathered 3,800 participants from over 90 countries for three days in Riyadh. The ambition was straightforward: open a global conversation about where capital meets consequence. From that single convening, NEOM was announced, a \$20 billion infrastructure commitment was made to Blackstone, and the world took notice of a new seat at the table.

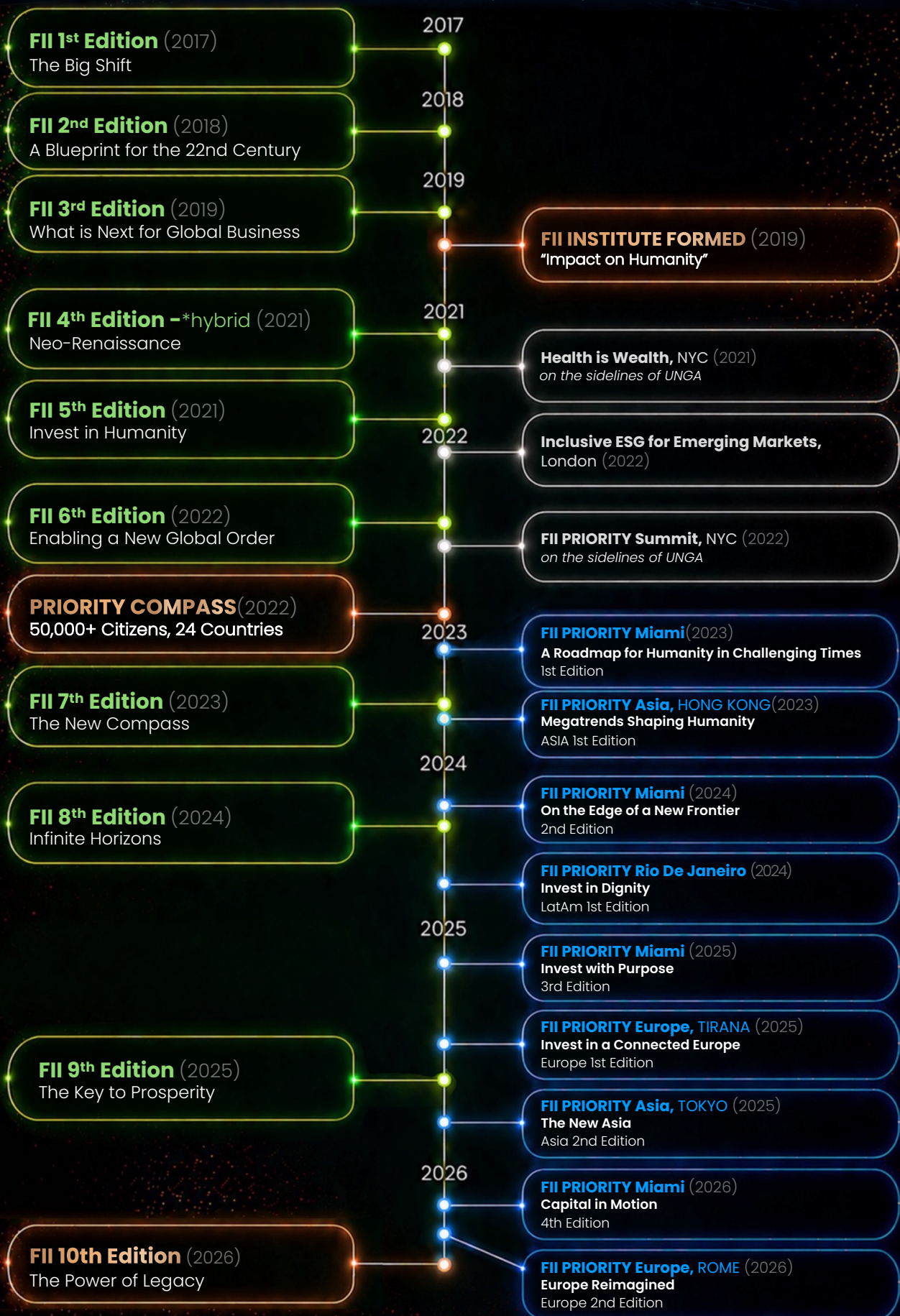

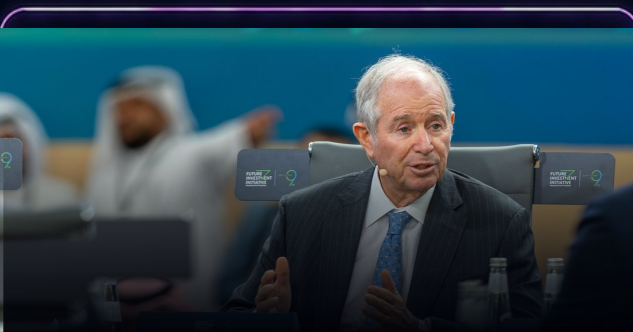
